NOTICE OF INSUFFICIENT REQUEST FOR SUMMARY DETERMINATION

Issue Date: February 9, 2022

On January 20, 2022, Co-Mo Electric Cooperative (Co-Mo) filed its application for approval of designated service boundaries in parts of Cooper County, Missouri, pursuant to §386.800, RSMo. On January 19, the Commission issued its order joining Union Electric Company, d/b/a Ameren Missouri (Ameren Missouri), establishing a deadline for intervention, and directing a response. On February 9, 2022, Ameren Missouri filed its response and a motion to dismiss.

The Commission finds that Ameren Missouri's motion to dismiss constitutes a request for summary determination because it presents factual matters beyond Co-Mo's original application. Motions for summary determination are subject to Commission Rule 20 CSR 4240-2.117. Ameren Missouri's motion does not comply with the requirements of that procedural rule.

Accordingly, the Commission will not take up the motion to dismiss as currently filed.
