On June 10, 2022, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (EMM) filed its 2022 annual update of the Integrated Resource Plan (IRP) it first presented to the Commission in its 2021 triennial IRP filing in File No. EO-2021-0035. On the same day, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (EMW) filed its annual update of the IRP it first presented to the Commission in File No. EO-2021-0036. Both EMM and EMW filed an IRP annual update summary report on July 15, 2022.

As permitted by Commission Rule 20 CSR 4240-22.080(3)(D), the Commission's Staff, Sierra Club, Renew Missouri, and Council for the New Energy Economics filed comments about that report. At the direction of the Commission, EMM and EMW responded to those comments on September 15, 2022.

The Commission's rule regarding annual updates to a utility's IRP requires the utility to make a filing and provides stakeholders an opportunity to file comments. It does not contemplate any action by the Commission to either approve or reject any of those

filings. Consequently, since no further action by the Commission is required, the Commission will close these files.

1. These files are closed.
2. This order shall be effective on October 2, 2022.
