CORRECTED ORDER DIRECTING NOTICE OF FILING

On April 15, 2022, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (Evergy Metro) filed its 2021 Renewable Energy Standard (RES) Compliance Report and its 2022 Annual RES Standard Compliance Plan, as required by Commission Rule 20 CSR 4240-20.100(8). Additionally, Evergy Metro requested a variance from 20 CSR 4240-20.100(8)(A)1.I(V) regarding the provision of meter readings used in the calculation of payments to Renewable Credit Vendors.

Commission Rule 20 CSR 4240-20.100(8)(D) requires the Staff of the Commission to review RES compliance reports and plans and file a report of its review with the Commission within 45 days of the date of filing.¹ The rule also allows the Office of the Public Counsel and other interested persons or entities to file comments within the same 45-day period.² Monday, May 30, 2022, is 45 days from the filing date of April 15, 2021, but it falls on the Memorial Day holiday, so comments on Evergy Metro's RES Compliance

Report and Plan are due no later than Tuesday, May 31, 2022.³ Any objection to the request for a variance shall also be filed on the same date.

The Commission will direct that notice of this filing be given to potentially interested persons, as required by Commission Rule 20 CSR 4240-20.100(8)(C).

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide notice of this order to each party to Evergy Metro's current general rate case, File No. ER-2022-0129.

2. The Commission's Data Center shall provide notice of this order to the county commission of each county within Evergy Metro's service area.

3. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the General Assembly representing residents of the counties within Evergy Metro's service area, as well as to the news media serving residents of those counties.

4. Any objection to the request for a variance shall be filed no later than May 31, 2022.

5. This order shall be effective when issued.
