### INTERIM RATE ADJUSTMENT ORDER APPROVING TARIFF AND PRESCRIBING FILING FORMAT

The Missouri Public Service Commission is approving the tariff to which the

Commission assigned tracking no. YE-2010-0577 ("tariff"). The tariff increases Union

Electric Company d/b/a AmerenUE's ("AmerenUE") fuel and purchased power adjustment

("FPA") by \$1.37 per month for the average residential customer of AmerenUE. The

Commission is also prescribing a filing format for AmerenUE's reports.

#### A. Procedure

The statutes allow AmerenUE:

. . . an interim energy charge, or periodic rate adjustments outside of general rate proceedings to reflect increases and decreases in its prudently incurred fuel and purchased-power costs, including transportation. <sup>[1</sup>]

Such charges and adjustments are the product of a contested case<sup>2</sup> and periodic review,<sup>3</sup>

both done under Commission regulations.<sup>4</sup>

Pursuant to those provisions, the Commission set the terms of AmerenUE's FPA<sup>5</sup> and conducted two reviews according to the following schedule:

Period 3 is the subject of the tariff.

On March 25, 2010, AmerenUE filed the tariff with a supporting affidavit. On April 19,

2010, the Commission's staff ("Staff") filed its recommendation with supporting affidavits,

and filed a clarification on April 27, 2010. The Commission received no other filings.

### **B.** Fuel and Purchased Power Adjustments

The tariff increases AmerenUE's fuel and purchased power adjustments from current

levels<sup>6</sup> as follows by customer class.

The increase will begin with the June 1, 2010 billing month and end with the May 31, 2011 billing month.

The FPA is the difference between AmerenUE's actual fuel and purchased power costs net of off-system sales (together, "net fuel costs") and the kilowatt hours ("kWhs") sold during the period multiplied by the Net Base Fuel Costs (NBFC) in AmerenUE's tariff. During the accumulation period, a decline in off-system sales resulted in greater net fuel costs, resulting in a greater number to multiply by NBFC. The parties agree that AmerenUE's net fuel costs account for the increase because they are up by \$47,507,064, of which AmerenUE passes 95% on to its customers, as reflected in the tariff.

The tariff complies with the Commission's regulation and orders, according to Staff's recommendation. The recommendation favors granting the tariff subject to true-up and prudence reviews. Therefore, the Commission will grant such approval.

#### C. Reports

The recommendation also asks that if AmerenUE continues to file its monthly and quarterly reports in EFIS in Adobe format, the Commission order AmerenUE to also file its past and future monthly and quarterly reports in Excel format with formulas intact and not password protected. The due date for AmerenUE to file a response was April 29, 2010.<sup>7</sup> As

of the date of this order, AmerenUE filed no response. Therefore, the Commission will grant that request.

### THE COMMISSION ORDERS THAT:

1. The tariff assigned tracking no. YE-2010-0577 is approved to become effective on May 25, 2010.

format, AmerenUE shall also file its past and future monthly and quarterly reports in Excel format with formulas intact and not password protected.
