On March 8, 2017, the Commission issued an order granting an application by Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company ("Company") to modify certain demand-side programs. On March 8, 2017, the Company filed revised tariff sheets with an effective date of April 7, 2015, purporting to correct a typographical error and remove incorrect references to Commission rule 4 CSR 240-20.094(4). The Commission will direct its Staff to review the revised tariff sheets and submit a recommendation. The Commission will also provide an opportunity for other parties to comment on the tariff sheets.

1. No later than March 20, 2017, Staff shall review the revised tariff sheets submitted by Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company and file a recommendation as to whether the tariff sheets should be approved.

- 2. Any party wishing to respond or comment on the revised tariff sheets submitted by Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company shall file its response no later than March 20, 2017.
