On May 4, 2018, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company filed revised tariff sheets with an effective date of June 3, 2018, to reflect revisions due to modifications to the Availability and Program Provisions sections of the Business and Residential Programmable Thermostat, Demand Response Incentive, Whole House Efficiency, and Income-Eligible Multi-Family tariff sheets.
