ORDER TO SUPPLEMENT APPLICATION

The application seeks authorization for a transfer of assets. The application sets forth the effect on tax revenues of certain political subdivisions ("affected political subdivisions") ¹ as the governing statute requires. ² But the governing statute requires the Commission to know all counties into which affected political subdivisions reach.³

That is because the governing statute requires the Commission to notify any county containing any part of any affected political subdivision:

The commission shall send a copy of all information obtained by it as to what . . . impact such [transaction] will have on the tax revenues of various political subdivisions to the county clerk of each county in which any portion of a political subdivision which will be affected by such disposition is located. [4]

That statute requires the Commission to send information to the clerk of any county, not only where the assets are located, but any other county into which any such political

subdivision reaches. Some political subdivisions may reach across county lines, not only into a neighboring county, but beyond.

The application lists three counties⁵–Cole, Miller, and Osage—but it is unclear whether that list exhausts the counties entitled to notice, so the Commission will order the application supplemented to state whether any other county is entitled to notice.

THE COMMISSION ORDERS THAT:

- 1. No later than September 8, 2015, the applicants shall file a supplement to the application stating whether any part of any affected political subdivision is located within any county other than Cole, Miller, and Osage.
 - 2. This order shall be effective when issued.
