**ORDER DIRECTING NOTICE AND SETTING DEADLINE FOR FILING OF
STAFF RECOMMENDATION**

On October 8, 2015, Union Electric Company d/b/a Ameren Missouri and Boone Electric Cooperative ("Boone Electric") filed a Joint Application for Authority to Transfer Customers Between Electric Supplier ("collectively, "Applicants"). The Applicants seek to transfer the duty to provide electrical service for a 155 acre tract of land located at the south end of South Hagans Road in Boone County, Missouri from Boone Electric to Ameren Missouri. The property at issue is owned by Ms. Laverne Garrett. Section 393.106, RSMo,¹ authorizes the Commission to order a change of suppliers if it is in the public interest for a reason other than a rate differential.

The Commission will direct the Commission's Staff to file a recommendation on the application. Although Ms. Garrett signed a letter in June memorializing the agreement to transfer service, the Commission will direct she be provided notice of the application.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall send a copy of this order and the application to Ms. Laverne Garrett at:

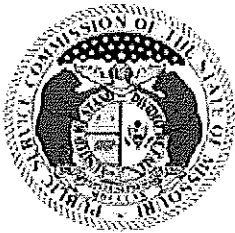




