Enclosed for submission to the Missouri Public Service Commission ("Commission") are revised Sheet Nos. 2, 37, 40, 41, and 42 for incorporation into Preferred Long Distance, Inc.'s ("Preferred") Missouri switched exchange access tariff, Missouri P.S.C. Tariff No. 2.

With this filing, Preferred complies with the Federal Communications Commission's ("FCC") Report and Order and Further Notice of Proposed Rulemaking, in Docket Nos. WC Docket No. 10-90, et al., FCC 11-161 (the "ICC/USF Transformational Order"), as amended. Specifically, Preferred reduces its intrastate terminating switched exchange access rate by fifty percent of the differential between its intrastate rates and corresponding interstate rates pursuant to the ICC/USF Transformational Order. The Company also introduces separate originating switched exchange access rates that mirror its existing switched exchange access rates, adds Shared Port and Tandem Transport Fixed rate elements pursuant to the FCC's June 5, 2012 Clarification Order, DA 12-870, and removes the Tandem Transport mileage bands above zero to four miles in favor of a single Tandem Transport per mile rate element set at the zero to four mileage band. Lastly, the Company deletes rates for services provided in the former Embarq Missouri, Inc., and CenturyLink Operating Companies (CenturyLink Missouri, Inc.) service territories as Preferred does not, nor has it, provided service in those incumbent local exchange carrier operating territories.

Also enclosed pursuant to the Commission's March 4, 2011 Order in File No. TT-2012-0317 is Preferred's completed proprietary demand data spreadsheet in the format requested by the Commission. The Company also provides separate calculations demonstrating how its rates were derived. An August 15, 2012 effective date is requested, 60 days from the issue date pursuant to the Commission's March 4, 2011 Order, unless a July 3, 2012 effective date is possible, consistent with the FCC's Clarification Order.
