On August 28, 2017, North American Telecommunications Corporation (North American) notified the Commission that the company no longer wished to be registered as an IVoIP provider in Missouri.

On April 2, 2015, the Commission granted North American registration to provide IVoIP services in the State of Missouri in File Number DA-2015-0228.

The Commission will direct its Staff to review the request and file a recommendation regarding the cancellation of North American's IVoIP registration.

### THE COMMISSION ORDERS THAT:

1. No later than September 18, 2017, the Staff of the Missouri Public Service Commission shall file a recommendation regarding North American's request to cancel its IVoIP registration.

2. This order shall be effective when issued.
