ORDER CANCELING REGISTRATION

Issue Date: July 5, 2018

Effective Date: July 15, 2018

On June 6, 2018, Staff filed a motion requesting the Commission cancel Apptix, Inc.'s ("Apptix") registration to provide Interconnected Voice over Internet Protocol service ("IVoIP") in the state of Missouri. The Commission granted Apptix its IVoIP registration in the state of Missouri in File No. DA-2017-0031.

Staff states in its motion that on May 9, 2018, the company notified the Commission that it no longer wished to be registered as an IVoIP provider in Missouri.

On June 20, 2018, the Commission issued an Order Establishing Time to Respond allowing parties to file an objection or request a hearing no later than July 2, 2018. No objections or requests for a hearing were filed.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹

Based on Apptix's request and Staff's motion, the Commission finds that the IVoIP registration granted to Apptix, Inc., shall be canceled.
