## ORDER CANCELING IVOIP REGISTRATION

Issue Date: July 13, 2022

Effective Date: August 12, 2022

On June 1, 2022, Enqwest LLC (Enqwest) filed a letter notifying the Commission that it wished to cancel its registration to provide Interconnected Voice over Internet Protocol (IVoIP) service in Missouri. The Commission previously granted that registration in File No. DA-2017-0185 on January 14, 2017.

The Commission directed its Staff to respond to Enqwest's notice and, on July 12, 2022, Staff filed a recommendation that the Commission cancel the registration to provide IVolP.

The Commission has the authority to cancel an IVoIP registration pursuant to Section 392.410.5, RSMo (2016), which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.” The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. W.D. 1989). No parties have intervened in this matter.

Based on Enqwest's request and Staff's recommendation, the Commission will cancel Enqwest's IVolP registration.

**THE COMMISSION ORDERS THAT:**

1. The registration to provide IVolP services granted to Enqwest in File No. DA-2017-0185 is canceled.
2. This order shall be effective on August 12, 2022.
3. This file may be closed on August 13, 2022.
