### ORDER CANCELING AUTHORITY

Issue Date: July 24, 2023

Effective Date: August 23, 2023

On March 23, 2023, the Staff of the Commission (Staff) filed a motion asking the Commission to cancel the registration to provide interconnected voice over Internet protocol (IVoIP) services of KrombieTech, LLC (KrombieTech or The Company). The Commission granted KrombieTech a registration in File No. DA-2006-0330.

Staff's motion states that KrombieTech failed to file an annual report for calendar years 2018, 2019, 2020, and 2021. KrombieTech also failed to file its Statement of Revenue for calendar year 2018, 2019, 2020, and 2021. KrombieTech also failed to pay its annual assessment for fiscal years 2021 and 2023. Staff recommended that the Commission cancel the Company's certificate.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." The Commission issued notice and allowed time to request a hearing. The Company has not responded.

Based on Staff's motion, the Commission finds that the registration granted to KrombieTech shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The registration to provide interconnected voice over Internet protocol (VoIP) services of KrombieTech, LLC granted in File No. DA-2016-0330 is canceled.
2. This order shall become effective on August 23, 2023.
3. This case may be closed on August 24, 2023.
