## ORDER CANCELING AUTHORITY

Issue Date: July 24, 2023

Effective Date: August 23, 2023

On March 24, 2023, the Staff of the Commission (Staff) filed a motion asking the Commission to cancel the registration of Wireless Investments, LLC (Wireless or The Company) to provide interconnected voice over internet protocol (IVoIP). The Commission granted Wireless registration to provide IVoIP service in File No. DA-2019-0303.

Staff's motion states that Wireless notes on its 2021 Statement of Revenue that it no longer wished to provide IVolP services in Missouri. Staff recommended that the Commission cancel the Company's registration.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.” The Commission issued notice and allowed time to request a hearing. The Company has not responded.

Based on Staff's motion, the Commission finds that the registration granted to Wireless shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The registration provide interconnected voice over internet protocol service authority granted to Wireless in File No. DA-2019-0303 is canceled.
2. This order shall become effective on August 23, 2023.
3. This case may be closed on August 24, 2023.
