ORDER SETTING A PROCEDURAL CONFERENCE

On September 30, 2008,¹ Aquila, Inc. d/b/a KCP&L Greater Missouri Operations Company ("Aquila") filed an application with the Missouri Public Service Commission, pursuant to Section 393.170, 393.171, RSMo 2000,² 4 CSR 240-2.060 and 4 CSR 240-3.105(1)(B) requesting that the Commission grant it a Certificate of Convenience and Necessity ("CCN") for two facilities previously approved by the Commission; (a) the South Harper power plant and related infrastructure and (b) the Peculiar 345 kV substation recently annexed by the City of Peculiar, both of which are located in Cass County, Missouri. Dogwood Energy, L.L.C., the County of Cass, Missouri, and the Sedalia Industrial Energy Users' Association were granted intervention on October 21.

No party, to-date, has requested a hearing or identified a position contrary to the grant of the CCN. Consequently, the Commission shall set a procedural conference to

further the resolution of this matter.

THE COMMISSION ORDERS THAT:

1. The parties shall appear at a procedural conference to be held on November 6, 2008, beginning at 9:00 a.m. The procedural conference will be held in Room 305 at the Commission's offices in the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, a building that meets the accessibility standards required by the Americans With Disabilities Act. 2. This order shall become effective immediate upon issuance.
