Dear Judge Dale:

On Thursday, February 22, 2007, Ms. Cathy Orler and I visited with Judge Harold Stearley over the telephone pertaining to three data requests she had submitted in early February to Folsom Ridge LLC and Big Island Homeowners Water and Sewer Association, Inc. in this referenced matter. The Respondents had objected to two of the data requests and as for the other, Ms. Orler was not satisfied with the answer that was given.

During the conference, the Respondents agreed to prepare from its records the following: 1) A list of current water customers; 2) a list of current sewer customers; 3) a list of customers who are connected to either system who are subject to the Amended and Restated Covenants and Conditions, or who have ratified the covenants and conditions; 4) a list of customers who are connected to either system who have not ratified the covenants and conditions; and 5) a list of individuals who are not connected to the systems, who have not ratified the covenants and conditions but who are receiving bills from the Association for other charges. This was agreed to resolve the issues raised by Ms. Orler's data requests and Respondents' objections and responses to those data requests.

Under cover of this letter I have attached two spreadsheets, one relating to the water system and the other relating to the sewer system each containing the information I have described above. The Respondents are prepared to stipulate to the accuracy of these documents.
