On February 16, 2022, Cable One VoIP LLC d/b/a Sparklight (Sparklight) filed a letter with the Commission to provide notice that it seeks to cancel its registration to provide Interconnected Voice over Internet Protocol service on a statewide basis. The Commission granted Sparklight its registration in Case No. DA-2022-0007 on July 15, 2021.

The Commission will direct its Staff to review the notice and file a recommendation regarding cancellation of Sparklight's registration.

THE COMMISSION ORDERS THAT:

1. No later than March 9, 2022, the Staff of the Missouri Public Service Commission shall file with the Commission a recommendation regarding the cancellation of Sparklight's registration to provide Voice over Internet Protocol service.
2. This order is effective when issued.
