ORDER CANCELING SERVICE AUTHORITY

Issue Date: August 23, 2022

Effective Date: September 22, 2022

On August 10, 2022, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the registration of interconnected voice over internet protocol (IVoIP) service authority of Triggerfish Corporation (Company). On May 4, 2016, the Commission registered the Company to provide IVoIP in File No. DA-2016-0270. Staff's motion states that the Company requested that the Commission cancel its IVoIP authorization.

On August 11, 2022, the Commission issued its order that anyone wishing to respond to Staff's motion or request a hearing do so by filing a pleading no later than August 22, 2022. There were no such filings. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, the Commission may cancel the certificate based on Staff's motion.

THE COMMISSION ORDERS THAT:

1. The IVoIP service authority of Triggerfish Corporation is canceled.
2. This order shall be effective on September 22, 2022.

3. This file shall be closed on September 23, 2022.
