MOTION FOR EXTENSION

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”) and for its *Motion for Extension* respectfully states:

1. On April 15, 2021, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (“Evergy West”) filed its 2020 Renewable Energy Standard (RES) Compliance Report (“Report”) and 2021 Annual RES Compliance Plan (“Plan”), as required by Commission Rule 20 CSR 4240-20.100(8).

2. The next day, April 16, 2021, the Commission issued its *Order Directing Notice of Filing* in both dockets, ordering Staff to review Evergy West’s Report and Plan, and file its own reports detailing Staff’s findings within forty-five days, per Commission Rule 20 CSR 4240-20.100(8)(D). The Commission ordered Staff to file its reports no later than June 1, 2021.¹

3. Staff has two data requests awaiting responses due by June 3 and June 15, 2021 in File No. EO-2021-0346. Staff has also indicated a number of corrections needed regarding Evergy West’s current Report and Plan.

4. In order to give Evergy West time to respond to Staff’s data requests and to discuss the necessary corrections, and give Staff the necessary time to analyze and incorporate the

responses into its reports, Staff respectfully requests an extension through June 22, 2021 per Commission Rule 20 CSR 4240-2.050(3)(A).

WHEREFORE, Staff respectfully submits this *Motion for Extension*, and hereby requests the Commission approve Staff's anticipated June 22, 2021, date for filing its reports.
