### NOTICE OF DEFICIENCY

Issue Date: October 15, 2021

On October 6, 2021, Lewis County Rural Electric Cooperative Association (Lewis County Cooperative) and Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed a Joint Motion for Approval of First Addendum to their Territorial Agreement, executed on March 30, 2000 and approved by the Commission in Case No. EO-2000-0603. Commission Rule 20 CSR 4240-4.017 requires that an applicant file a notice at least 60 days before filing their application. That requirement can be waived by the Commission for good cause. Commission Rule 20 CSR 4240-4.017(D) provides that good cause for a waiver of the 60-day notice requirement may include "a verified declaration from the filing party that is has had no communication with the office of the commission within the prior one hundred fifty (150) days regarding any substantive issue likely to be in the case or that circumstances prevented filing the required notice and delaying the filing for sixty (60) days would cause harm.

The Commission will not take action on Lewis County Cooperative's and Ameren Missouri's joint motion for approval of addendum to their Territorial Agreement until this deficiency is corrected.
