**NOTICE OF TARIFF FILING AND ORDER ESTABLISHING TIME TO
FILE RECOMMENDATIONS**

On August 15, 2016, Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”) filed an application requesting that the Missouri Public Service Commission approve a tariff authorizing a pilot program to install and operate electric vehicle charging stations at locations within Ameren Missouri’s service area along the Interstate 70 corridor between St. Louis and Boonville, Missouri and in Jefferson City, Missouri. Ameren Missouri also filed tariff sheets with an effective date of October 15, 2016, to implement the pilot program.

The Commission will provide notice of this tariff filing to the parties in Ameren Missouri’s current rate case, File No. ER-2016-0179. In addition, the Commission will establish a date for the filing of applications to intervene, direct its Staff to file a recommendation about the tariff and Ameren Missouri’s application, and establish a date for the filing of recommendations by other parties.

THE COMMISSION ORDERS THAT:

1. The Commission’s Data Center shall send a copy of this order to all parties to File No. ER-2016-0179.

2. Any appropriate person or entity wishing to apply to intervene shall do so no later than August 31, 2016.

4. The Commission's Staff shall file a recommendation regarding Ameren Missouri's application and associated tariff no later than September 28, 2016.

5. Any other party wishing to file a recommendation regarding Ameren Missouri's application and associated tariff shall do so no later than September 28, 2016.

5. This order shall be effective when issued.
