### ORDER DIRECTING FILING

On August 27, 2018, KCP&L Greater Missouri Operations Company (GMO) filed tariff sheets, Tariff Tracking No. JE-2019-0026, to establish its Limited Large Customer Economic Development Rider in compliance with Section 393.1640, RSMo. At Staff's request, the Commission suspended those tariff sheets by order issued on September 25, 2018, pending resolution of a potential substantive dispute. On October 4, 2018, GMO filed substitute tariff sheets and a motion requesting expedited consideration and approval of the tariff so that the substituted tariff sheets become effective on October 19, 2018.

Because of the request for expedited consideration and approval, the Commission will shorten the time for responses to the proposed tariff sheets to allow the Commission to take up the request at its October 10 agenda meeting. Any order approving the tariff would need to have at least a ten-day effective date, unless a party demonstrates extraordinary circumstances that would justify a shorter effective date. The Commission will also direct GMO to clarify its request by stating whether any harm to the public or the company would come from the tariff becoming effective on October 20, 2018, rather than October 19, 2018.

#### THE COMMISSION ORDERS THAT:

- 1. Any responses to the motion for expedited consideration and approval of the substituted tariff sheets shall be filed no later than 4:00 p.m., October 9, 2018.
- 2. No later than 4:00 p.m. on October 9, 2018, GMO shall clarify its request for expedited approval of its tariff by stating what, if any, harm to the public or the company would come from the tariff becoming effective on October 20, 2018, rather than October 19, 2018.
- 3. The requirement that the Staff of the Missouri Public Service Commission file a status report on October 10, 2018, is canceled.
  - 4. This order shall become effective when issued.
