## **ORDER PROVIDING NOTICE, ESTABLISHING INTERVENTION DEADLINE, AND SETTING TIME FOR RESPONSES**

On September 30, 2016, Union Electric Company, d/b/a Ameren Missouri filed a request for certain variances from parts of 4 CSR 240-22 with regard to its next triennial Integrated Resource Plan (IRP) compliance filing due to be filed on October 1, 2017. Since the Commission's decision to grant or deny the requested variances may affect the substance of Ameren's IRP filing, the Commission will provide notice to other potential interested parties and the public, and will establish an intervention deadline. In addition, the Commission will establish a date for its Staff and other interested parties to offer recommendations regarding Ameren's request for variances.

### **THE COMMISSION ORDERS THAT:**

1. The Commission's Data Center shall mail a copy of this order to all parties to Union Electric Company, d/b/a Ameren Missouri's current rate case, ER-2016-0179, and previous integrated resource plan proceeding, EO-2015-0084.

2. The Commission's Public Information Office shall make notice of this order available to the media serving Union Electric Company, d/b/a Ameren Missouri's service

area and to the members of the General Assembly representing Union Electric Company, d/b/a Ameren Missouri's service area.

3. Any person wishing to intervene in this matter shall file an application to do so no later than October 24, 2016.

4. Any party wishing to respond to Union Electric Company, d/b/a Ameren Missouri's request for variances shall do so no later than November 14, 2016.

5. This order shall be effective when issued.
