ORDER ESTABLISHING APPROPRIATE NONDISCLOSURE FORM

On March 30, 2022, the Commission filed its *Order Regarding Ameren Missouri's Motion to Allow Selected Access to Highly Confidential Information and Motion for Expedited Treatment*. In that order, the Commission ordered that certain employees of Ameren Missouri be granted access to highly confidential information for use during this proceeding, and that they submit an appropriate non-disclosure form and file it with the Commission.

On March 31, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed a motion with an attached alternative nondisclosure agreement marked Exhibit A. Ameren Missouri explains that the nondisclosure agreement form attached to the Commission's order was inappropriate because it contradicted itself. Ameren Missouri requests that the Commission either correct its order *nunc pro tunc*, or confirm that the nondisclosure agreement attached to Ameren Missouri's motion is an appropriate non-disclosure form in this action.

The Commission finds that the non-disclosure form attached to Ameren Missouri's motion is an appropriate non-disclosure form for the purpose of this action. That form will be incorporated into this order.

THE COMMISSION ORDERS THAT:

1. The Nondisclosure Agreement attached to this order as “Exhibit A” is an appropriate non-disclosure form for the purpose of this action.
2. This order shall be effective when issued.
