STAFF’S NINTH PRUDENCE REVIEW REPORT

COMES NOW Staff of the Missouri Public Service Commission and submits Staff’s Ninth Prudence Review Report (incorporated by reference) of costs and revenues related to the Fuel Adjustment Clause (“FAC”) for the electric operations of Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri” or “Company”). In support thereof, Staff states as follows:

1. On March 4, 2022, Staff filed *Staff’s Notice of Start of Ninth FAC Prudence Review* (“Notice”) informing the Commission that it had begun its review of the costs and revenues subject to Ameren Missouri’s FAC.

2. The Notice described Staff’s plan to conduct a prudence review of the costs and revenues associated with Ameren Missouri’s FAC for the period June 1, 2020 through September 30, 2021. This Review Period corresponds to the 35th through 38th accumulation periods (each accumulation period is four-months) of Ameren Missouri’s FAC.

3. Staff has completed its prudence review and provides a detailed discussion of its findings in Staff’s *Ninth Prudence Review of Costs Related To The Fuel Adjustment Clause For The Electric Operations Of Union Electric Company d/b/a Ameren Missouri* (“Prudence Review Report”) submitted concurrently herewith. As a result of its prudence review, and as

more fully explained in the Prudence Review Report, Staff found no evidence of imprudence for the items it examined for the period of June 1, 2020 through September 30, 2021.

WHEREFORE, Staff requests the Commission accept its Prudence Review Report of Ameren Missouri's FAC and that the Commission issue such further orders herein as the Commission deems proper.
