On May 18, 2022, Jennifer Dutcher filed an application requesting that her electric supplier be changed from Evergy Missouri West, Inc. (EMW) to Platte-Clay Electric Cooperative, Inc. (Platte-Clay). EMW responded on June 28, 2022. The Staff of the Commission (Staff) filed its recommendation that the Commission approve the change of supplier request on October 31, 2022.

The Commission will set a deadline for responses to Staff's recommendation and also set a deadline for hearing requests.

### THE COMMISSION ORDERS THAT:

1. No party is required to respond, but any party that wishes to respond to Staff's recommendation, or request a hearing, shall do so on or before November 10, 2022.
2. This order shall be effective when issued.
