ORDER EXTENDING THE TIME FOR A COMMISSION DECISION, DENYING PUBLIC COUNSEL'S REQUEST FOR WRITTEN NOTICE TO ALL LANDOWNERS, AND ORDERING A RESPONSE

Ameren Missouri (collectively, "Applicants") filed a stipulation and agreement along with

a territorial agreement in File No. EO-2022-0190. The Applicants contemplate the

approval of the stipulation and agreement along with the proposed territorial agreement.

The Commission opened File No. EO-2022-0332 to address the territorial agreement.

The law requires the Commission to rule on a territorial agreement application no later than 120 days from the application's filing date, unless good cause exists to order otherwise, and provides the right to a hearing.¹ However, a hearing may be waived by agreement of the parties.² Because that territorial agreement was last amended on October 19, 2022, and because there is disagreement over the approval of that territorial

agreement, there is good cause to extend the time for the Commission to rule on this territorial agreement.

On November 23, 2022, Staff filed a recommendation in EO-2022-0332 to approve the territorial agreement subject to conditions.

Public Counsel filed a response to the proposed territorial agreement. Public Counsel proposes that either the Commission direct the Applicants to each provide direct mailed notice to every landowner within the proposed service areas designated for that electrical provider, or that the Commission reject the territorial agreement.

The Applicants separately responded to Public Counsel's response opposing mailing notice to all landowners. Ameren Missouri's response states:

Consequently, if the Commission were inclined to choose OPC's option A³, Ameren Missouri would prefer that the Commission simply decline to approve the Territorial Agreement. Given the unique circumstances of this case and the passage of time, i.e., given that the case started almost 11 months ago, that the subdivision developer has already started development, and that Co-Mo has proceeded to build new infrastructure, if the Commission did decline to approve the Territorial Agreement, the Company will not object to a Commission order allocating the Fox Hollow Subdivision to Co-Mo.

The Commission will not order the Applicants to send mailed notice to every landowner as the territory the territorial agreement addresses is devoid of electrical service at this time, with the exception that the territorial agreement "may transfer one or two customers from Ameren to Co-Mo." Thus the Commission will direct Public Counsel to file a pleading stating whether it wishes to have an evidentiary hearing pursuant to Section 394.312.5, RSMo, prior to the Commission considering approval of the territorial agreement.

THE COMMISSION ORDERS THAT:

1. The timeline for a Commission decision pursuant to Section 394.312.4 RSMo, is extended.

2. Public Counsel's request to have notice mailed to every landowner in the area subject to the territorial agreement is denied.

3. No later than January 11, 2023, Public Counsel shall file a pleading stating if it desires an evidentiary hearing regarding the territorial agreement.

4. This order is effective when issued.
