KCP&L Greater Missouri Operations Company (GMO) filed a revised tariff on March 31, 2017, to adjust its Renewable Energy Standard Rate Adjustment Mechanism (RESRAM) rates. GMO's tariff revision carries a June 1, 2017 effective date.

Before the Commission considers GMO's tariff, it will direct its Staff to file a recommendation regarding that tariff.

**THE COMMISSION ORDERS THAT:**

1. Staff shall file its recommendation regarding KCP&L Greater Missouri Operations Company's tariff no later than May 12, 2017.
2. This order shall be effective when issued.
