**ORDER GRANTING APPLICATION TO INTERVENE OUT OF TIME**

On August 15, 2016, Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”) filed an application requesting that the Missouri Public Service Commission approve a tariff authorizing a pilot program to install and operate electric vehicle (“EV”) charging stations at locations within Ameren Missouri’s service area. On August 15, 2016, the Commission issued an order directing notice of the application and setting a deadline of August 31, 2016 for persons requesting to intervene in this matter.

On October 28, 2016, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company (“Movants”) filed an application for leave to intervene out of time. Movants state that they have constructed electric vehicle charging stations in their service territory and filed an electric vehicle charging station tariff in a pending rate case. Movants were not aware that electric vehicle policy that may affect their interests would be raised in this proceeding until a discussion by the Commissioners during an agenda meeting on October 26, 2016. No party has objected to the application to intervene out of time. The application satisfies all requirements of Commission Rule 4 CSR 240-2.075 and intervention will be granted.

**THE COMMISSION ORDERS THAT:**

1. The application to intervene out of time filed by Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company is granted.
2. This order shall be effective when issued.
