**NOTICE OF TARIFF FILING AND ORDER ESTABLISHING TIME TO  
INTERVENE AND FILE RECOMMENDATIONS**

On November 27, 2017, Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”) filed an application requesting that the Missouri Public Service Commission approve a tariff authorizing the Renewable Choice Program, which is a new service in which qualifying customers can elect to participate in a subscription-based renewable energy program. The company also seeks authority from the Commission to defer certain costs and revenues that are presently included in its fuel adjustment clause to a regulatory asset or liability until such time as appropriate revisions to its existing fuel adjustment clause can be implemented. Ameren Missouri filed tariff sheets with an effective date of January 25, 2018, to implement the Renewable Choice Program.

The Commission will provide notice of this application and tariff filing to the parties in Ameren Missouri’s most recent rate case, File No. ER-2016-0179. In addition, the Commission will establish a date for the filing of applications to intervene, direct its Staff to file a recommendation about the tariff and Ameren Missouri’s application, and establish a date for the filing of recommendations by other parties.

**THE COMMISSION ORDERS THAT:**

1. The Commission's Data Center shall send a copy of this order to all parties to File No. ER-2016-0179.
2. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the General Assembly representing the counties within Union Electric Company d/b/a Ameren Missouri's service area, and to the news media serving that service area.
3. Any appropriate person or entity wishing to apply to intervene shall do so no later than December 11, 2017.
4. The Commission's Staff shall file a recommendation regarding Ameren Missouri's application and associated tariff no later than January 5, 2018.
5. Any other party wishing to file a recommendation regarding Ameren Missouri's application and associated tariff shall do so no later than January 5, 2018.
5. This order shall become effective when issued.


