**ORDER GRANTING MOTION FOR EXTENSION OF TIME TO FILE STAFF
RECOMMENDATION AND COMMENTS**

On January 4, 2018, the Commission’s Staff and Union Electric Company d/b/a Ameren Missouri filed a joint motion for a one-month extension of time to file Staff’s recommendation regarding Ameren Missouri’s application in this matter. Staff and Ameren Missouri request that the deadline be extended until February 5, 2018 in order to conduct additional discovery and negotiations. Staff and Ameren Missouri represent that the Office of the Public Counsel and intervenors do not oppose this request, and Ameren Missouri will extend the effective date of its tariff an additional 30 days from January 25, 2018 to February 24, 2018. The Commission finds the request reasonable and will grant the motion.

THE COMMISSION ORDERS THAT:

1. Staff and Union Electric Company d/b/a Ameren Missouri’s Joint Motion for Extension of Time to File Recommendations is granted. The deadline for filing a Staff recommendation is extended until no later than February 5, 2018.

2. The deadline for any party wishing to comment on the application submitted by Union Electric Company d/b/a Ameren Missouri is also extended until no later than February 5, 2018.

3. This order shall be effective when issued.
