ORDER MODIFYING PROCEDURAL SCHEDULE

On September 28, 2018, Union Electric Company d/b/a Ameren Missouri, the Staff of the Missouri Public Service Commission, and the Office of the Public Counsel filed a motion requesting that the procedural schedule in this matter be amended. The movants explained that a settlement on the line extension portion of the Charge Ahead filing has been reached in principle, but a written agreement will not be finalized for a few more days. Therefore, the movants request that the requirement for filing rebuttal testimony related to the line extension issue be extended from October 1 to October 5, 2018. The Commission will grant the extension. All other portions of the procedural schedule, including filing rebuttal testimony on all other issues, remain in effect.

THE COMMISSION ORDERS THAT:

1. The procedural schedule previously ordered in this matter is amended to allow the rebuttal testimony with regard to the issue of the line extension policy to be filed no later than October 5, 2018.

2. This order is effective when issued.
