ORDER DIRECTING FILING AND SETTING TIME FOR RESPONSES

Issue Date: February 1, 2023

Effective Date: February 1, 2023

On December 13, 2022, The Empire District Electric Company d/b/a Liberty (Liberty) filed an application to discontinue providing solar rebates. Liberty also requested a waiver of Commission Rule 20 CSR 4240-4.017(1) requiring a minimum of 60 days’ notice prior to filing a new case with the Commission. The Commission issued notice and directed its Staff to file its recommendation or a status report stating when it expected to file its recommendation.

On January 26, 2023, Staff filed a status report indicating that it anticipates filing its recommendation by March 29, 2023. The Commission will direct Staff to file its recommendation by that date. Additionally, the Commission will set a time for responses to Staff’s recommendation and requests for hearing.

THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendation or request for additional time no later than March 29, 2023.
2. Any responses to Staff’s recommendation shall be filed no later than April 10, 2023.
3. Any requests for hearing shall be filed no later than April 10, 2023.

4. This order shall be effective when issued.
