**STAFF RECOMMENDATION**

**COMES NOW**, Staff of the Missouri Public Service Commission and submits its Staff Recommendation in this matter and in support thereof respectfully states as follows:

1. On February 14, 2023, the Commission issued an *Order Suspending Tariff Sheet and Directing Filing* (“Order”) in this matter, which ordered Staff to file its recommendation no later than May 31, 2023. Filed concurrently herewith, in memorandum form, is Staff’s recommendation, which is incorporated herein by reference.

2. As discussed in detail in the accompanying Staff recommendation memorandum, Staff recommends that the Commission issue an order (1) approving the tariff sheet that is the subject of this proceeding<sup>1</sup> (Tariff Tracking No. JE-2023-0131), after being corrected to reflect the correct sheet numbering (see footnote below), to go into effect for service on and after June 12, 2023, and (2) that the Commission further order Evergy to file a public version of the data required by 20 CSR 4240-3.155(4).
