ORDER GRANTING EXTENSION OF TIME

On May 18, 2022, Jennifer Dutcher filed an application with the Missouri Public Service Commission requesting that her electric supplier be changed from Evergy Missouri West, Inc. (EMW) to Platte-Clay Electric Cooperative, Inc. (Platte-Clay). The Commission directed responses from EMW and Platte-Clay by June 21, 2022. On June 21, EMW filed a motion requesting an extension of one week to file its response.

In support of its request, EMW states it recently became aware that service to the property may be subject to a 1991 Territorial Agreement. EMW therefore requests an additional week to study potential impacts of the 1991 Territorial Agreement.

The Commission finds EMW's request to be reasonable and will grant it. The Commission will likewise extend the deadline by one week to receive a recommendation from the Staff of the Commission (Staff). The Commission also notes it has received the directed response from Platte-Clay on June 21, but will allow for further response if Platte-Clay wishes.

THE COMMISSION ORDERS THAT:

1. EMW's request for an extension of time to file its response is granted.

2. EMW shall file its response, or a further request for an extension of time, on or before June 28, 2022.

3. Platte-Clay is not required to file any additional response, but if it wishes to supplement its response filed on June 21, it shall do so on or before June 28, 2022.

4. Staff shall submit its recommendation, or a request for an extension of time, on or before July 12, 2022.

5. This order shall be effective when issued.
