**ORDER SUSPENDING FILING REQUIREMENTS
AND DIRECTING FILING**

On September 28, 2022, the Staff of the Commission (Staff) filed a request to suspend the requirement that it file a recommendation by September 29, 2022. Staff also asked that the Commission order Co-Mo Electric Cooperative and Union Electric Company d/b/a Ameren Missouri to file either a pleading with the territorial agreement they wish approved, or a status report. In support of its position, Staff states that it has been advised that a modified legal description is being reviewed by Co-Mo Electric Cooperative, Union Electric Company d/b/a Ameren Missouri, and the City of Boonville. Staff can make no recommendation until a new legal description is filed.

Accordingly, the Commission will suspend the filing requirements of its September 22, 2022, *Order Directing Staff to File a Recommendation and Setting a Time for Responses*, and direct the joint applicants to file either a modified legal description for the Commission’s consideration or a status report.

THE COMMISSION ORDERS THAT:

1. The filing requirements contained in the Commission’s *Order Directing Staff to File a Recommendation and Setting a Time for Responses* are suspended.

2. Co-Mo Electric Cooperative and Union Electric Company d/b/a Ameren shall file either a modified legal description for the Commission's consideration, or a status report no later than October 14, 2022.

3. This order is effective when issued.
