THE OFFICE OF THE PUBLIC COUNSEL'S RESPONSE

COMES NOW the Office of the Public Counsel (Public Counsel) and for its Response states as follows:

1. On September 29, 2014, KCP&L Greater Missouri Operations Company (GMO) filed a proposed Missouri Energy Efficiency Investment Act (MEEIA) Program Income-Eligible Weatherization tariff sheet with the Missouri Public Service Commission (Commission). The proposed tariff revision consisted of the addition of: (1) reallocation of funds from United Services to West Central Missouri Community Action; and (2) explanatory language below the allocation table describing the reallocation of funds.
2. The proposed tariff sheet filed by GMO contained an issue date of September 29, 2014 and an effective date of October 29, 2014. GMO also filed a Motion for Expedited Treatment, requesting that the Commission order the proposed tariff sheet to become effective October 9, 2014.
3. On September 30, 2014, the Commission issued an Order stating that any party wishing to respond to GMO's Motion for Expedited Treatment and its proposed tariff revision must do so no later than October 6, 2014.

4. Public Counsel has reviewed GMO's proposed MEEIA Program Income-Eligible Weatherization tariff sheet and request for expedited treatment and now states that it has no opposition to GMO's requests.

WHEREFORE, Public Counsel respectfully submits its Response.
