On August 27, 2018, KCP&L Greater Missouri Operations Company filed tariff sheets, Tariff Tracking No. JE-2019-0026, to establish its Limited Large Customer Economic Development Rider in compliance with Section 393.1640, RSMo. At Staff's request, the Commission suspended those tariff sheets by order issued on September 25, 2018, pending resolution of a potential substantive dispute. The Commission will order its Staff to file a status report stating if the parties have resolved their issues or if a procedural conference is necessary to establish a procedural schedule.

THE COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service Commission shall file a status report no later than October 10, 2018.
2. This order shall become effective when issued.


