STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission ("Staff") and for its *Staff Recommendation* that the Commission grant expedited approval of Tariff No. YE-2020-0208 and reject Tariff No. YE-2020-0091, states as follows:

- 1. On May 13, 2020, Staff, Union Electric Company d/b/a Ameren Missouri ("Ameren"), Renew Missouri Advocates d/b/a Renew Missouri ("Renew Missouri") and the Office of the Public Counsel ("OPC") filed a *Unanimous Stipulation and Agreement* ("the Agreement"). The Commission approved the Agreement in an order issued on May 28, 2020, with an effective date of June 27, 2020.
- 2. Also on May 28, 2020, Ameren filed a new tariff in compliance with the terms of the approved Agreement, Tariff No. YE-2020-0208. Ameren also requested expedited treatment of the tariff, with an effective date of June 8, 2020
- 3. Following its review of Tariff No. YE-2020-0208, Staff recommends that the Commission grant expedited approval, and change the effective date of the Commission's May 28, 2020 order to June 8, 2020.
- 4. Staff would like to note that the original tariff filed on November 25, 2019, bears Tariff No. YE-2020-0091. Staff recommends that tariff be rejected, so that it does not go into effect at the end of its suspension on June 24, 2020.

WHEREFORE, Staff respectfully submits this *Staff Recommendation*, and prays that the Commission grant expedited approval for Tariff No. YE-2020-0208, filed May 28, 2020, and reject Tariff No. YE-2020-0091, filed November 25, 2019.
