ORDER DIRECTING STAFF TO FILE RECOMMENDATION AND ESTABLISHING TIME FOR ANY OTHER PARTY TO FILE A RECOMMENDATION

On January 12, 2022, the Commission issued a report and order regarding an application filed by Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively, Evergy) for approval of a transportation electrification portfolio. In that report and order, the Commission rejected the implementing tariffs filed by Evergy, but authorized it to file new tariffs to comply with the report and order. Evergy filed its compliance tariffs on March 1, 2022, to be effective on March 31, 2022.

The Commission will direct its Staff to file a recommendation regarding those compliance tariff filings, and will establish a time for any other party to file a recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendation regarding the compliance tariffs filed by Evergy no later than March 15, 2022.
2. Any other party that wishes to file a recommendation regarding the compliance tariffs filed by Evergy shall do so no later than March 15, 2022.

3. This order shall be effective when issued.
