ORDER APPROVING COMPLIANCE TARIFFS

Issue Date: March 16, 2022

Effective Date: March 31, 2022

On January 12, 2022, the Commission issued a report and order regarding an application filed by Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively, Evergy) for approval of a transportation electrification portfolio. In that report and order, the Commission rejected the implementing tariffs filed by Evergy, but authorized it to file new tariffs to comply with the report and order. Evergy filed its compliance tariffs on March 1, 2022, to be effective on March 31, 2022.

The Commission ordered its Staff to file a recommendation regarding those compliance tariff filings by March 15, 2022, and ordered any other party wishing to file a recommendation to do so by that date. Staff filed a recommendation on March 15, 2022, advising the Commission to approve Evergy's compliance tariffs. No other party filed a recommendation.

The Commission has reviewed the proposed tariff sheets and Staff's recommendation. The Commission concludes the submitted compliance tariff sheets are consistent with the report and order and should be approved. The Commission also finds

it reasonable to make this order effective in less than thirty days so that the effective date of the order will match the effective dates of the tariff sheets.

THE COMMISSION ORDERS THAT:

1. The tariff revisions submitted by Evergy Missouri Metro and Evergy Missouri West on March 1, 2022 (Tracking Nos. YE-2022-0228 and YE-2022-0229) are approved, as substituted, to be effective on March 31, 2022. The tariff sheets approved are:
