**ORDER APPROVING TARIFF**

Issue Date: November 17, 2022

Effective Date: December 1, 2022

Evergy Missouri West, Inc., d/b/a Evergy Missouri West (Evergy West) filed a revised tariff on September 30, 2022, to adjust its Renewable Energy Standard Rate Adjustment Mechanism (RESRAM) rates. The tariff revision carries a December 1, 2022 effective date.

The Commission's Staff filed a recommendation and memorandum regarding the tariff on October 31, 2022. Staff explains that the RESRAM rate proposed by Evergy West is \$0.00088. Customers using 1,000 kWh per month will see a \$0.01 decrease per month and will pay \$0.88 per month. More than ten days have passed since Staff filed its recommendation, and no party has responded to that recommendation.<sup>1</sup>

Staff recommends the Commission either approve the tariff, or allow it to go into effect by operation of law. The Commission will approve the tariff. The Commission will further authorize this order to take effect in less than thirty days to match the effective date of the tariff.
