STAFF'S SECOND RECOMMENDATION

COMES NOW the Staff ("Staff") of the Missouri Public Service Commission ("Commission") and recommends Commission approval of the Industrial Demand Response Pilot Program tariff filed October 23, 2007 by Union Electric Company d/b/a AmerenUE ("AmerenUE"). In support thereof, the Staff respectfully states as follows:

- 1. The Commission opened this case, pursuant to its Report And Order in AmerenUE's recent general rate increase case (Case No. ER-2007-0002), for the purpose of considering AmerenUE's proposed Industrial Demand Response Pilot Program ("IDR"). On July 2, 2007, AmerenUE filed proposed tariff sheets designed to implement the IDR. The Commission declined to adopt an August 31, 2007 Staff recommendation of approval of this initial proposal, in favor of further negotiations among the parties. A subsequent proposal, filed on October 23, 2007 and bearing an effective date of November 22, 2007, is the product of those negotiations.
- 2. In the aforementioned Report And Order, the Commission stated: "If AmerenUE does not file a tariff that is acceptable to all other parties, the Commission may impose the

revisions urged by MEG."² As noted in the attached Memorandum (Appendix A), while in particular the Office of the Public Counsel has not been able to agree on all elements of the currently proposed tariff, the tariff is acceptable to the Missouri Energy Group ("MEG") and the Staff. In its Memorandum, the Staff sets out a comparison of the MEG proposals in the aforementioned AmerenUE rate case with those currently proposed in AmerenUE's October 23, 2007 tariff filing.

3. Having completed its review, the Staff recommends Commission approval of the following tariff sheets:
