ORDER GRANTING REQUEST FOR EXTENSION OF TIME

On October 1, 2021, Grundy Electric Cooperative and the City of Galt, Missouri filed a Joint Application for approval of a written territorial agreement and for approval of a change of electric supplier. The Commission directed the Staff of the Missouri Public Service Commission (Staff) to file a recommendation regarding the Joint Application no later than November 5, 2021.

On November 4, 2021, Staff filed a *Motion for Additional Time*, stating that Staff is still reviewing and waiting on information to provide a fully informed recommendation on the Joint Application. Staff requested that the recommendation deadline be moved to no later than December 1, 2021.

The Commission finds the motion reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's motion for additional time to file its recommendation is granted. Staff shall file its recommendation as soon as possible, but no later than December 1, 2021.

2. This Order shall be effective when issued.
