NOTICE ACKNOWLEDGING DISMISSAL

Issue Date: August 23, 2022

On March 18, 2022, White River Valley Electric Cooperative, Inc. (White River) filed an application with the Commission requesting approval as electric supplier for a soon-to-be-developed vacant lot owned by Elevate Branson, a non-profit entity with its principal place of business in Branson. The vacant lot is approximately five acres and currently receives no electric service. The vacant lot is adjacent to an approximately 1.1 acre parcel owned by Elevate Branson that currently receives electric service from White River. Elevate Branson desired to have both parcels serviced by White River, but The Empire District Electric Company d/b/a Liberty had expressed a desire to provide electric service to the five acre parcel.

On August 22, 2022, White River and Liberty filed a *Joint Notice of Dismissal* in which the two entities stated that they had reached an agreement to fully address and resolve the issues raised in White River's application. As a result, the two entities have agreed to dismiss this application and will initiate a new case before the Commission seeking approval for an amendment to their territorial agreement.

Commission Rule 20 CSR 4240-2.116(1) states that an applicant may dismiss an application without an order of the Commission at any time before prepared testimony

has been filed or oral evidence has been offered. The parties have not offered prepared testimony or oral evidence. The Commission, therefore, will take notice of the dismissal.

This case is now closed.
