ORDER ESTABLISHING TIME TO RESPOND TO MOTION FOR PROTECTIVE ORDER

On April 14, 2022, The Empire District Electric Company d/b/a Liberty (Liberty) filed a motion asking the Commission to issue a protective order regarding its 2021 Renewable Energy Standard (RES) Compliance Report and 2022 RES Compliance Plan, which were both filed along with the motion. Certain items were designated as confidential and highly confidential within the filings. Liberty indicates certain information may need the extra protection afforded by a highly confidential designation.

Before ruling on the motion for protective order, the Commission will allow the other parties an opportunity to respond. The Commission notes that Commission Rule 20 CSR 4240-2.135(4)(A) provides that while a motion for protective order is pending the party requesting greater protection will be afforded the protection sought.

THE COMMISSION ORDERS THAT:

1. Any party wishing to respond to Liberty's Motion for Protective Order shall do so no later than April 20, 2022.
2. This order shall be effective when issued.
