**ORDER GRANTING MOTION FOR EXTENSION OF TIME  
TO FILE STAFF REPORTS**

On April 15, 2022, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (Evergy Metro) filed its 2021 Renewable Energy Standard (RES) Compliance Report and its 2022 Annual RES Standard Compliance Plan, as required by Commission Rule 20 CSR 4240-20.100(8). Additionally, Evergy Metro requested a variance from 20 CSR 4240-20.100(8)(A)1.I(V) regarding the provision of meter readings used in the calculation of payments to Renewable Credit Vendors. On April 18, 2022, the Commission issued its corrected order directing notice of filing, requiring Staff to review RES compliance reports and plans and file its report no later than Tuesday, May 31, 2022. On May 23, 2022, Staff filed its motion requesting an extension of 45 additional days to file its reports, stating that additional information was requested from Evergy Metro, and that additional time was required to review that information. A 45-day extension will require Staff’s reports to be filed no later than Friday, July 15, 2022.

The Commission will grant Staff’s motion for a 45-day extension to file its reports and any objections to Evergy Metro’s request for a variance, and will extend the period

for the Office of the Public Counsel and other interested persons or entities to comment for 45 days as well.

**THE COMMISSION ORDERS THAT:**

1. Staff shall file its reports regarding its review of Evergy Metro's RES compliance reports and plans, and any objections to Evergy Metro's request for a variance, no later than July 15, 2022.

2. The Office of the Public Counsel, or any other interested persons or entities wishing to comment on Evergy Metro's RES compliance reports and plans or any objections to Evergy Metro's request for a variance, shall do so no later than July 15, 2022.

3. This order shall be effective when issued.
