## ORDER GRANTING EXTENSION OF TIME TO FILE STAFF RECOMMENDATION

Issue Date: August 31, 2022

Effective Date: August 31, 2022

On May 18, 2022, Jennifer Dutcher filed an application requesting that her electric supplier be changed from Evergy Missouri West, Inc. (EMW) to Platte-Clay Electric Cooperative, Inc. (Platte-Clay). The Staff of the Commission (Staff) was directed to produce a recommendation, or request an extension of time, on or before July 12, 2022, later extended to August 31, 2022.

On August 30, 2022, Staff requested an extension of time until October 30, 2022, to file its recommendation. In support of its request, Staff states it has issued data requests which will necessitate additional time to review. Staff also states it may need to perform a site visit to develop the appropriate recommendation.

The Commission finds Staff's request to be reasonable and will grant it.

### THE COMMISSION ORDERS THAT:

1. Staff's request for an extension of time to file its recommendation is granted.

Staff shall submit its recommendation, or a request for a further extension of time, on or before October 31, 2022.<sup>1</sup>


