On July 2, 2018, The Empire District Electric Company ("Empire") filed a tariff sheet under Tariff Tracking No. JE-2019-0002 to modify Empire's existing economic development rider that was established in a prior rate case, File No. ER-2012-0345. At Staff's request, the Commission suspended that tariff sheet by order issued on July 31, 2018 pending resolution of a substantive dispute. The Commission will order its Staff to file a status report stating if the parties have reached a settlement or whether a procedural conference is necessary to establish a procedural schedule.

THE COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service Commission shall file a status report no later than August 20, 2018.
2. This order shall become effective when issued.
