On October 18, 2018, Kansas City Power & Light Company (KCP&L) filed substitute tariff sheets in Tariff Tracking No. JE-2019-0025. Because KCP&L has previously asked that these tariffs become effective no later than November 3, 2018, the Commission will shorten the time for responses to the proposed tariff sheets to allow the Commission to take up the request at its October 24, 2018 agenda meeting. The Commission will also direct KCP&L to clarify its requested effective date and the reasons for that request.

### THE COMMISSION ORDERS THAT:

1. No later than October 22, 2018, Kansas City Power & Light Company shall clarify its requested effective date and the reason for that requested date.
2. Any responses to the substituted tariff sheets filed on October 18, 2018, in Tariff Tracking No. JE-2019-0025 shall be filed no later than 4:00 p.m., October 23, 2018.
3. This order shall become effective when issued.
